## STRUCTURED INVESTMENTS

Structured investments products (e.g., guaranteed investment contracts, repurchase agreements, and other similar arrangements) are contracts between an investor and an eligible counterparty that provides for a fixed (or floating) rate on deposited funds, while allowing for withdrawals at par for the permitted purposes established under the bond documents. BLX is poised to undertake a competitive bid process on your behalf to acquire structured investments products.

## OPEN MARKET SECURITIES

BLX's capabilities extend to the bidding of open market security portfolios for escrow funds, project funds, capitalized interest funds, and other bond proceeds. We utilize specialized optimization software to construct potential portfolios from the universe of permitted investments and evaluate the potential yield and earnings of open-market securities.

## REFUNDING AND DEFEASANCE ESCROWS

Open market securities are commonly used for refunding and defeasance escrows. While a State and Local Government Series ("SLGS") portfolio can be an optimal strategy, open market securities can often be secured at a lower cost and yield meaningful savings. We empower clients to choose between SLGS and open market securities based on real time pricing without incurring any additional expense. Hence, there is no downside to considering both strategies.

## COMPETITIVELY BID INVESTMENTS USING BLXBid

For structured products and open market securities, BLX undertakes a competitive process to solicit bids from eligible counterparties and dealers with the goal of achieving the best available price within the safe harbor (for federal tax purposes). We utilize our proprietary web-based bidding platform, BLXBid, to conduct the competitive procurement process. BLXBid is a live auction site that allows invited entities to submit a "sealed" bid within a specified time window. Financing team members can view the process in real time and quickly evaluate the bids, which is critical to the execution process. Post transaction, BLXBid provides permanent online access to transaction records to ensure efficient record keeping and compliance. Our team members take into account the timing of economic data releases, Treasury financing activities, and Federal Reserve open market operations that may affect market conditions and dealer availability.
